**Grace:** In early 2021, 13-year-old Grace made a significant attempt to end her life. Grace was living with her mother, her mother's partner and the youngest two of her siblings in a one-bedroom flat at the time. This event was subsequently followed by another attempt 4 months later.

Concerns about Grace's emotional state were first shared with professionals in 2020, five months before her significant attempt to end her life.

Following Grace's attempt to end her life in 2021, the family were supported under a child in need plan. There were various indicators that Grace's needs were not being met at home in the months that followed the attempt to end her life, and that her mental health was being impacted on by this and her history of emotional abuse and neglect.

CJ was a vulnerable young White British adult with a diagnosis of ASD and ADHD since the age of 5.

CJ frequently sought opportunities to change 'how he felt inside his head' and had a history of trying to 'get high'. This increased to using alcohol and drugs to excess. Inevitably, all these methods resulted in him needing emergency medical treatment.

CJ had a history of self-harm and was the subject of a safeguarding referrals as both a child and an adult. At the age of 15, CJ was taken into care by Warwickshire at his parents' request after they felt unable to care for him. Between the ages of 15 and 18 years old, CJ had experienced 12 different placements both in and outside of Warwickshire.

In late 2020, Police visited CJ at his new temporary accommodation at the request of his mother. Police sadly found CJ dead in his room.

The 2021–2022 annual report acknowledges the work of the partnership under the continued pressures and challenges presented by the Covid–19 pandemic. The work of the partnership remained focused around its strategic priorities, introducing new ways of working and protocols which helped to support improved safeguarding awareness, understanding and interventions when dealing with exploitation; the replacement of the former safeguarding thresholds for children introducing a new 'Spectrum of Support'; and refreshing risk assessment processes which better support the practice of Making Safeguarding Personal amongst adults and ensure the voice of the child is captured within children's cases.

# 'Core Safeguarding Practice' -

# Warwickshire Safeguarding's Latest Strategic Thematic Review

Warwickshire Safeguarding has now completed its second Strategic Thematic Review focusing on the topic of 'Core Safeguarding Practice' of children and adults. The final full report details learning identified from single agency self-evaluations, case file audits, professional surveys, conversations with professionals and feedback gathered from service users/carer's/families through the statutory reviews work.

25 agencies from statutory and voluntary organisations and service providers engaged in this strategic thematic review. A significant amount of information has been gathered and processed to provide an insight into all aspects of safeguarding work. areas of work which exemplify good practice, as well as identify practice where further development is required, both at multi-agency and single agency levels.

Appendix.1 at the end of the report provides a summary overview of the key strengths and areas for improvement requiring further development which have been identified through this review. Sitting alongside this are single-agency actions which have been identified and will be implemented by individual agencies. The Warwickshire Safeguarding Executive Board will oversee the delivery of the multi-agency action plan emerging from this review.

## ICB Arrangements

The Coventry and Warwickshire Integrated Care Board was formally established on the 1st July 2022. The Integrated Care Board (ICB) is responsible for commissioning NHS services on behalf of people in Coventry and Warwickshire. In consultation with local partners, it plans the delivery of services in a way that both meets local health and care needs and reduces inequalities between different groups.

The Board of the ICB is made up of senior leaders from a range of health and care organisations and its membership includes:

- The Chair
- 5 non-executive members
- 5 appointed executives
- 7 representatives from NHS providers, local authorities and primary care
- Representatives from Healthwatch and the Voluntary, Community and Social Enterprise sector

By bringing together the knowledge and experience of the board members and the organisations they represent, the ICB can make informed and joined up decisions about health and care provision across the region.

All ICBs across the country have the flexibility to make decisions that allow them to respond to the specific needs of the local population. In order to ensure the Coventry and Warwickshire ICB is delivering the services needed locally, their work will be informed by both the Integrated Care Partnership's (ICP) integrated care strategy and the Health and Wellbeing Strategies published by the Health and Wellbeing Boards in our region. Furthermore, they will consistently involve and consult with local communities to ensure the needs of our population are met.

# Warwickshire Director of Public Health Annual Report 2022 - 'Health and the High Cost of Living'

Directors of Public Health have a statutory requirement to write an annual report on the health of their population. The Director of Public Health Annual Report is a vehicle for informing local people about the health of their community, as well as providing necessary information for decision-makers in local health services and authorities on health gaps and priorities that need to be addressed.

The theme of this year's report is health and the high cost of living in Warwickshire. The report includes an overview of the health and wellbeing of the Warwickshire population and information on progress with the 2020/21 recommendations.

### 'NRM' - National Referral Mechanism

There is a national framework to assist in the formal identification and help to coordinate the referral of victims of modern slavery to appropriate services, known as the National Referral Mechanism. Certain public bodies such as local authorities and chief officers of Police have a statutory duty to refer.

# Safeguarding learners vulnerable to radicalisation

Support for those working in education settings with safeguarding responsibilities.

#### This guidance is for:

- designated safeguarding leads (DSLs)
- those working in education settings who have safeguarding responsibilities for keeping children, young people and adult learners safe in schools, colleges and further education independent training providers

This guidance has been developed by frontline practitioners in local authorities, with support from the Department for Education. It reflects learning since the implementation of the Prevent duty in 2015 under section 26 of the Counter Terrorism and Security Act 2015.
