




## **NEW - Published Review**

Provided below are details of the report which has been recently published by the partnership following the conclusion of the safeguarding review. Copies of the full reports relating to children and adults can be found by clicking on either of the following links:

James: In February 2021, James stabbed his father at home in an apparent act of self-defence. James's father was not seriously harmed but James and his family had been known to a wide range of services over a number of years. He was extremely vulnerable with several complex needs including risk of criminal exploitation, mental health issues, self-harm and suicide attempts, a history of traumatic childhood experiences and frequent cannabis misuse. He had missed a significant part of his secondary education. James experienced chaotic early life experiences and instability in his care arrangements moving between his parents care throughout his childhood. He had been involved with Child and Adolescent Mental Health (CAMHS) since the age of nine and there was an extensive history of mental health issues including nine recorded episodes of overdose and/or suicidal ideation. There were 37 recorded attendances at Accident and Emergency departments. James had been subject to a child in need plan and a child protection plan, and the family had been offered support from several agencies.

## Warwickshire Safeguarding Strategic Plan 2023-2026

Warwickshire Safeguarding Partnership launched it's new Strategic Plan for 2023 - 2026.

The streamlined plan sets out the Partnerships shared vision and actions that will help keep children, young people, and adults at risk safe from abuse and neglect and will support and enable local agencies to work together in a system where:

- Excellent practice is the norm
- Partners work collaboratively to achieve the same end goals
- Partner agencies hold one another to account effectively
- There is early identification of 'new' safeguarding issues
- · Learning is promoted and embedded
- Information is shared effectively
- The public can feel confident that children and adults are protected from harm

The Strategic Plan is a statutory requirement and sets out the Partnerships strategic priority areas of focus for 2023-2026 and will be reviewed annually.

#### YOUNG PEOPLE'S DASH RISK ASSESSMENT CHECKLIST

Did you know there is a version of the DASH for use with young people are experiencing domestic abuse?

The SafeLives DASH for adults has been amended for practitioners to use to identify risk in cases of domestic abuse, stalking and 'honour'-based violence for young people aged 13 to 17 years old.

The Young People's DASH Risk Checklist should be used with every young person who discloses that they are experiencing current domestic abuse. Similar to the adult DASH, the checklist offers an opportunity for practitioners to identify the levels of risk a young person may be exposed to, inform and make appropriate referrals to Children's Services/MARAC and offer support.

Children are negatively impacted by experiencing domestic abuse and without early intervention and support this negative impact can last through a child's life course.

Operation Encompass is a police and education early information safeguarding partnership enabling schools to offer immediate support to children experiencing domestic abuse. Operation Encompass aims, by directly connecting police and schools, to secure better outcomes for children, to enable schools to better understand the impact living with domestic abuse has upon children, to help schools to better understand a child's lived experience and to therefore be able to support and nurture each child, making a child's day better and giving them a better tomorrow.

#### Spread the word about #DogSafety

Recently we've seen several tragic dog attack fatalities, so it's paramount that families are equipped with the knowledge and skills they need to enjoy spending time with their dogs safely.

The Canine and Feline Sector Group Dog Safety Code highlights three crucial messages that all dog owners and families need to know:

- Be alert Always keep an eye on your dog around kids. Never leave them alone together
- Be aware Dogs use signals to tell us how they feel What is your dog telling you?
- Be safe Any dog can bite. Accidents happen fast.

We're encouraging safeguarding partners to display and share the infographic as widely as possible to get the #DogSafety message out there.

National Referral Mechanism (NRM)

There is a national framework to assist in the formal identification and help to coordinate the referral of victims of modern slavery to appropriate services, known as the National Referral Mechanism. Certain public bodies such as local authorities and chief officers of Police have a statutory duty to refer.

## The Child Sexual Abuse Review Panel (CSARP)

The Child Sexual Abuse Review Panel (CSARP) is a joint initiative between the National Police Chiefs' Council (NPCC) and Crown Prosecution Service (CPS) and reviews cases in England and Wales where a victim or survivor feel the decision to take no further action (NFA) in an investigation was unjust and would like the decision to be reconsidered. The CSARP was established in June 2013 to revisit cases that were not covered under the Victims' Right to Review (VRR) scheme. VRR was introduced to enable victims to seek a review of either a CPS or police decision to take no further action in respect of allegations they made; however, the scheme only applies to decisions made on or after 5 June 2013.

#### Cases will be considered if:

- The report is about an alleged sexual offence against the victim or survivor.
- The victim or survivor is referring to a report previously made to the police about the sexual offence.
- A decision to take no further action was taken by the police or by the CPS.
- The alleged sexual offences were committed when the victim or survivor was under 18 years of age.
- Police believe the alleged offender may still pose a risk.
- The alleged offence was committed in England and Wales.
- The case was investigated and marked no further action by police or CPS before 5 June 2013.

#### Cases will not be considered if:

- The victim or survivor hasn't previously reported the matter to the police as this will therefore be a new complaint that the police will need to investigate.
- New evidence has come to light prompting a fresh investigation by the police.
- The case was investigated and marked no further action by police or CPS before 5 June 2013 (after this date cases are covered by the Victims' Right to Review Scheme).
- The alleged offence did not take place in England or Wales.
