Welcome from Independent Chair & Scrutineer

This quarters newsletter shares the findings from the our local safeguarding reviews as well as the National review into the murders of Arthur Labinjo – Hughes and Star Hobson.

Once again the key findings include:

- · Weakness in information sharing
- Lack of escalation and weak decision making
- Multi-agency arrangements are fractured and fragmented
- Insufficient attention and investment in securing multi-agency expertise

But this time there is a single recommendation to "Develop a new approach to undertaking child protection work".

In developing new ideas and ways of working I am pleased that Warwickshire partners hold tight to the fundamental belief that safeguarding is everyone's business. However, partnership work is not straightforward and different views can by challenging.

I urge you to pay particular attention to the Warwickshire escalation policy and use your senior colleagues to support you in this difficult work by unlocking blocks in the system and finding ways to resolve intransigent problems across the professions as we all work together to make a difference.

Prada and Jordan: Both Prada and Jordan were young people under the care of the local authority. At the time of the incident, Prada was 17 years old, and Jordan was 15. One day in early 2020, Jordan had gone missing from her foster care placement and returned to the area of her family home. Later that day, Prada assaulted and stabbed Jordan. The girls were not known to each other previously, but Prada was understood to be linked to another young person involved in a feud with Jordan.

At the time of the assault Jordan was living in a foster care placement due to abuse and neglect within the family home. Prada was known to agencies due to concerns over her behaviour, violent outbursts, and missing episodes.

Charlie: In late 2019, a house fire consumed the upstairs floor of a family home. Neighbours raised the alarm and called the fire service, who responded very promptly. Charlie, who was 21 months old at the time of the incident, was rescued but found in a critical condition. Charlie's father was at work and her mother was at a neighbour's house. Charlie and her siblings were left unsupervised. The fire is believed to have been started by a lit candle towards the rear of the property. Charlie spent a lot of time in the hospital due to being unable to breathe unaided and injury resulting in severe burns. Charlie will require ongoing medical treatment for her injuries, which are life altering.

The National Child Safeguarding Review Panel has published the review into the murders of Arthur Labinjo – Hughes and Star Hobson.

The key findings include:

- · Weakness in information sharing
- Lack of escalation and weak decision making

- Insufficient attention and investment in securing multi-agency expertise

Recent spate of dog attacks

In the month of March, four children were viciously mauled by dogs. An eight year old was seriously hurt and three children under the age of 3 were killed. April 2022 two people killed, including a 3 year old boy.

Dog bites and attacks are increasing year on year. It is estimated that an additional 2 million dogs were brought in 2020 - 2021 compared to 2019. Sadly it is the most vulnerable who are most at risk from a serious dog attack.

Child Q

In Hackney, a black female child was strip searched by female police officers. The search took place on the school premises without an Appropriate Adult present and with knowledge that the child was menstruating, involved the exposure of Child Q's intimate body parts. This incident was incredibly distressing to the child. The family GP made a referral for phycological support after Child Q's mother made an appointment.



Supporting Providers to keep Children Safe

Warwickshire Safeguarding Partnership, Warwickshire County Council Missing and Child Exploitation Team and Warwickshire Police have been working together to develop a number of initiatives to support care providers when a child or younger person goes missing from care or supported accommodation.

A Children in Care Pack has been developed for those who provide care to children and young people, setting expectations as to how they can help keep children safe and protect children from criminalisation.

Early Help and Targeted Support Update ~ Carl Lewis, Headteacher Coach

Schools and other education settings in Warwickshire are currently completing the annual Safeguarding Audit. This is an annual event which helps Warwickshire to gather information about safeguarding in educational provisions.

This audit gives us the opportunity to gather information on the status of safeguarding in Warwickshire, to keep elected members informed and to help plan for training and support in the year ahead.

Areas that we anticipate greater demand in training for in the year ahead include mental health support, self-harm and the role of 'lessons learned' and safeguarding reviews.

Practitioner Escalation Protocol

Warwickshire's Practitioner Escalation Tool provides clear guidance for practitioners. The protocol offers a three stage procedure and includes a reporting and monitoring processes.

- Stage 1 Line Manager to Line Manager* Discussion
- Stage 2 Senior Manager to Senior Manager* Discussion
- Stage 3 Safeguarding Partnership

Practitioners are individually responsible for being satisfied about the substance and progress of safeguarding plans for service users. This protocol recognises this and provides a tool to support individuals to exercise this responsibility when they are concerned about the actions or inactions of other agencies or practitioners.
